

## OFFICIAL RULES FOR 2024 3XL UNDERWEAR CONTEST

NO PURCHASE OR PAYMENT NECESSARY TO ENTER OR WIN. A PURCHASE

WILL NOT INCREASE YOUR CHANCE OF WINNING

**1. Promotion Description:** The **2024 3XL Underwear** Contest (the "Contest") begins on Jun 1<sup>st</sup>, 2024, at 8:00 a.m. Eastern Daylight Time ("EDT") and the period for entering the Contest ends on June 30<sup>th</sup>, 2024, 11:59 p.m. EDT (the "Entry Period"). By participating in the Contest, each entrant unconditionally accepts and agrees to comply with and abide by these Official Rules and the decisions of Principle Business Enterprises, Inc. [PBE] ("Sponsor") which shall be final and binding in all respects.

**2.
