## INCONTINENCE CARE AND EXPOSURE TIME REDUCTION PROJECT



### Introduction

A large Northeast VA facility agreed to do an independent 4-week product trial with Tranquility® Premium superabsorbent briefs. The facility was looking to improve their product usage, as well as lessen caregiver and patient exposure by reducing the number of brief changes per day versus the current incontinence product. They hypothesized that by reducing the number of patient brief changes per day there would be an overall supply savings, as well as a positive impact on staff through reduced labor burden.

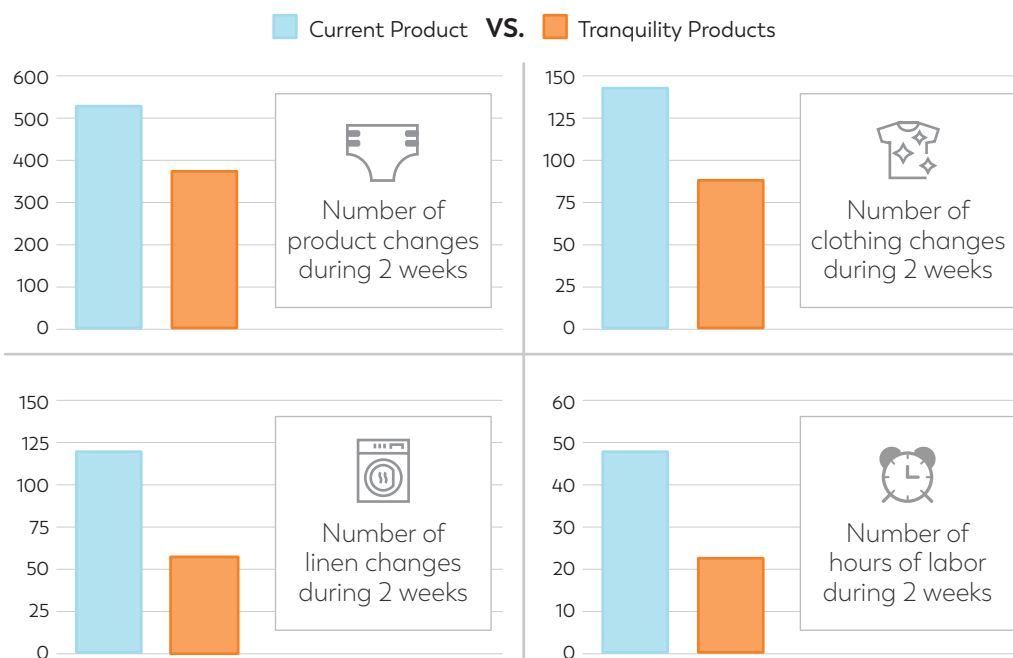
28-day Trial | 2 weeks in current brand | 2 weeks in Tranquility brand | Unbiased trial; no product training

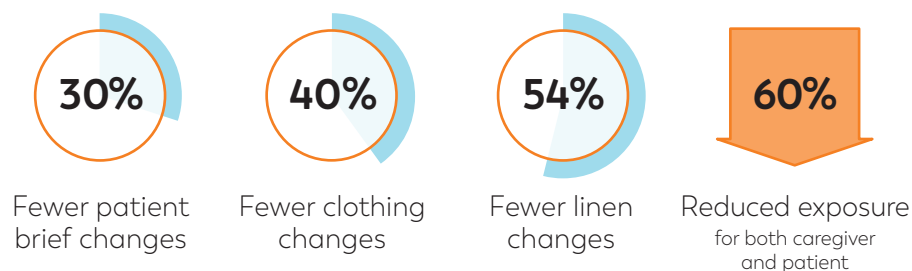
### Product Trial Results
